1. Pre-Inspection Setup

- Verify proper authorization and access permits.
- Confirm required documentation (previous test records, specs, procedures).
- Ensure safety precautions: PPE, isolation, barriers, fiber disposal containers.
- Review job hazard analysis (JHA) and site hazards.

2. Site Preparation & Safety

- Underground utilities marked before trenching/drilling.
- Work area cleared, safe, and compliant with OSHA 29 CFR 1910.268.
- Emergency exits accessible; first-aid supplies stocked.

3. Physical Cable & Pathway Inspection

- Check cable routing for proper support and no sharp bends or kinks.

- Verify bend-radius compliance per manufacturer/TIA standards.
 - Ensure no crushing, pinching, or stress points along the route.
 - Confirm cable trays, conduits, and management hardware are intact.
4. Patch Panel & Hardware Inspection
- Patch panels securely mounted and free of damage.
 - Ports accurately labeled; unused ports capped.
 - Cable management rings/guides functional; no broken tabs.
 - Excess cable neatly bundled without over-tightening ties.
5. Connector & Ferrule Inspection
- Inspect all fiber connectors using a fiber inspection microscope.
 - End-faces must be free of scratches, pits, chips, or contamination.
 - Verify ferrule polish type and connector gender match design.
 - Ensure all unmated ports have dust caps installed.
6. Splice & Enclosure Inspection
- Cleave angle within specification (
